LORD MAYOR

Meeting with Co-Chief Executive of Friends of the Earth

On 1 March the Lord Mayor met the Co-Chief Executive of Friends of the Earth, discussing sustainability and climate change. In a very constructive engagement, the meeting explored areas where the agendas of the City of London Corporation and Friends of the Earth could potentially align. There was agreement on the need to build on the public's understanding and support for addressing climate change. The meeting also explored the possibility of sharing research and data that reinforce the importance of a sustainable and inclusive transition away from fossil fuels. Friends of the Earth acknowledged the opportunities the Mayoralty had in provoking and leading relevant conversations in this arena in the finance world.

Roundtable with High Commissioner for Australia

On 2 March, during the UK Government's fourth round of Free Trade Agreement negotiations with Australia, the Lord Mayor attended a roundtable promoting regulatory cooperation in reducing frictions in the Financial and Professional Services sector (FPS). The Australian High Commissioner the Hon George Brandis QC also attended the event. The Lord Mayor spoke about the City's competitiveness and recovery from the pandemic, highlighting the importance of the Recovery Taskforce and the integral role proactive policy plays to ensure the right skills and working environment exist to support collaboration and innovation. He also spoke about digital trade and the position of regulation to help protect it against fragmentation.

City, University of London Space Institute Launch

On 3 March, in his capacity as Rector of City, University of London, the Lord Mayor spoke at a virtual launch event of the University's London Space Innovation Centre. This centre will act as a hub for coordinating and promoting multidisciplinary research, education and enterprise projects in space-related fields. It will also facilitate collaboration between academia, industry, and the public sector with a focus on connecting the space sector in London with other sectors and industries. Demonstrating its presence in another sector where London's innovative nature comes to the fore, the global space sector (of which London has 6.5%) is expected to continue grow strongly with estimates forecasting \$1tn in annual revenue by 2040.

Virtual visit to Birmingham

On 4 and 5 March, the Lord Mayor virtually visited Birmingham in a series of engagements with a focus on tech sectors. He met key regional stakeholders including West Midlands Growth Company and Greater Birmingham and Solihull Local Enterprise Partnership; business meetings included lawtech firm Clarilis and online property lending platform CrowdProperty. The Lord Mayor also participated in a roundtable on the city region's new SuperTech cluster, which focuses on the enabling technologies which underpin a range of tech sectors; and met representatives of the University of Birmingham's Green Innovation Centre.

Virtual visit to Latin America

From 8-10 March, the Lord Mayor took part in a virtual visit to Latin America in collaboration with the UK Government, focussing on Brazil and Chile. The visit helped to build relationships with new senior Government officials in the UK and Latin America as well as existing City investors and firms looking to set up in the UK. The conversations focussed on the government and FPS sector's work to build sustainable policy and how the UK can support new regulatory frameworks such as Open Banking.

UK Board of Trade Meeting

On 10 March, the Lord Mayor attended the second full Board of Trade meeting, following the launch of the first Board of Trade Report – 'Global Britain, Local Jobs'. The Lord Mayor spoke on the Green Trade Paper as well as Adviser Engagement. He updated the Board on the City Corporation's work running up to COP26 and led discussions on how Advisers can engage between meetings to further Board objectives

Lloyd's fireside chat event: Future of Cities – 11 March

On 11 March, the Lord Mayor was a panellist at an event chaired by Bruce Carnegie-Brown, Chairman of Lloyd's, alongside Dan Hill, Visiting Professor of Practice at UCL Institute for Innovation and Public Service and Nicola Millard, Principal Innovation Partner at BT. Topics discussed included Revitalising the City after the pandemic and the role of business in shaping the future of the City. The audience comprised insurance leaders and insurance market participants. Key messages were the London Recharged report, finding that businesses are still committed to Central London with the number of recent planning approvals for new office towers in the Square Mile showing there is still a big demand for business bases in the City.

Institute of Directors International Women's Day Webinar

On 12 March the Lord Mayor, alongside other speakers such as Julie Kapsalis (Coast to Capital LEP) spoke at the Institute of Directors International Women's Day Webinar discussing Mental Health, Emotional Resilience and how to deal with uncertainty and adversity. He touched upon the City Corporation's work on the Women in Finance Charter and the Lord Mayor's Appeal's efforts in the She Can Be campaign as well as Place2Be, the children's mental health charity.

CHIEF COMMONER

Gearing up for the *Rentrée* – Expect the Unexpected

Members are eagerly awaiting the **Rentrée** but no one can yet be quite sure how it is going to pan out. The year since the first lockdown has taught us to expect the unexpected, and the road to full recovery may take months if not years.

If all goes to plan, and the roll-out of the vaccination continues to have positive results, there will be a partial reopening of Guildhall on 17 May and a further opening after 21 June. In all probability, though, this will not mean full and unfettered access as before. Some restrictions in terms of social distancing are likely to remain in place for several months, and it may not be until the autumn before the City of London Corporation finds a new way of working in a post-pandemic world. Hybrid meetings, with some members continuing to participate from home, are likely to become standard practice. Government legislation will need to be modified to allow this to happen.

In line with Government public health advice, and as COVID-19 recedes, the City Corporation is keen to promote a return of activity to the Square Mile and to encourage and incentivise people back to their offices. Much depends on when and under what conditions the Government lifts the work from home recommendation.

There are some positive steps planned for the road back to normal. The Lord Mayor is expecting to return to Mansion House in mid-April, the Guildhall Club hopes to open its doors for tables of up to six from 17 May, and the Remembrancer's office is again taking bookings for social events. The Waterloo & City line is expected to re-open.

For many Members, a key moment will be the first Court back in Great Hall; this could be the Court scheduled for 22 July – the first after 21 June.

On the corporate hospitality side at Guildhall, a number of events are planned for the summer and there are currently substantial bookings in the diary for the autumn. Enquiries for the latter part of the year and for spring 2022 are increasing. The general outlook, however, is that business meetings and events are not expected to return to pre-COVID-19 levels for a substantial period, perhaps up to two years.

In another sign that the worst of the pandemic may be over, the COVID-19 testing centre in Guildhall Yard is scheduled to close down in the next few months, although testing will continue at other venues in the City.

Events that have not been able to take place there, such as passing out parades for new recruits to the City of London Police, will be brought back. The two most recent police graduation parades have been held at Wellington Barracks – the latest on 12 March attended by the Lord Mayor, the Chief Commoner, the Remembrancer and the Chairman of the City of London Police Authority Board.

Scottish Government/City of London Corporation – Race to Zero panel event

The Policy Chair took part in the high-level panel discussion introducing the Scottish Government's Race to Zero programme of events on 9 March. The event saw the Policy Chair further cement our collaboration with the Scottish Government and our support for their advanced green agenda. The Policy Chair also set out the City of London Corporation's own activity in this space, from the civic ambition embodied in our Climate Action Strategy, to our work on green finance on the road to COP26 in Glasgow.

London Recovery and London Transition Board

In recent weeks, the Policy Chair attended the latest meeting of the London Transition Board, which is co-chaired by the Secretary of State for Housing, Communities and Local Government and the Mayor of London. The Board provides strategic direction across London for the next phase of the COVID response and restart, focusing on the system-wide issues London faces. It has oversight of the London Strategic Coordination Group (SCG) which is chaired by the Town Clerk. The Board is expected to continue to meet every six weeks for the duration of the Government's roadmap out of lockdown. Its work is in parallel with the London Recovery Board, chaired by the Mayor of London and the Chair of London Councils, bringing together borough leaders and representatives from trade unions, education, health and police. The board aims, among other things, to reverse unemployment caused by the economic fallout of COVID-19, support communities, reduce inequality, and deliver a greener London.

Department for International Trade (DIT): The Business of Resilience Conference

On 24 March, the Policy Chair was invited by DIT to take part in the Business of Resilience conference. The two-day event was focused on examining the increasing needs to build economic and societal resilience across the public and private sector against forms of systematic risks. In recent years forms of risk include climate change, natural catastrophes and environmental stress, highlighting the need for greater collaboration and innovation and across industries including insurance, finance, regulation and technology. The Policy Chair chaired a panel on *Enabling Environment* with executives from the London Market Group, EY, Clyde & Co. The discussion centred on the ways in which the City is a global leader for resilience finance and services, allowing other countries to establish their enabling environment.

Thirty influential leaders join Government-backed taskforce to boost socio-economic diversity

The UK Government has commissioned the City Corporation to lead a taskforce, which aims to boost socio-economic diversity at senior levels across UK financial and professional services (FPS). It will be chaired by the Policy Chair, and Co-Chairs Alderman Vincent Keaveny, Sandra Wallace (Social Mobility Commission) and Andy Haldane (Bank of England). A group of [30 senior leaders from across FPS](#) (plus six regulators appointed as observers) were publicly announced by the Government on 22 March.

International Women's Day (IWD) Event

In celebration of IWD, the City Corporation hosted a virtual event to highlight the impact of the pandemic on women, both in the workplace and at home. The event focused on themes such as the reversion to traditional gender roles, domestic violence and the success of female scientists and thinkers who provided invaluable contributions to solutions to the pandemic. The event witnessed over 500 attendees listen in to speeches made by the Policy Chair and Alderman Alison Gowman as well as a Q&A session featuring leading directors, partners and CEOs across various sectors.

PARLIAMENTARY/GLA

Integrated Review

The Prime Minister made a statement to the House announcing the publication of the Government's integrated review of security, defence, development, and foreign policy. Boris Johnson spoke of using the UK's G7 Presidency and hosting of COP 26 as an opportunity to pursue international agreement on pandemic preparedness and net zero targets, respectively. The Prime Minister also announced his invitation to Australia, South Korea, and India to attend the G7 summit in June and will visit India next month. Johnson committed the UK to remaining a nuclear-armed power with "global reach" and military capabilities across all five operational domains - cyber, space, maritime, land and air. Johnson also reaffirmed his commitment to NATO and announced (formally) that HMS Queen Elizabeth will lead a carrier strike group to the Indo-Pacific and back. On China, the Prime Minister said he noted "deep concern" on the mass detention of Uyghurs and China's approach to Hong Kong but said, "we will also work with China where that is consistent with our values and interests, including in building a stronger and positive economic relationship and in addressing climate change." While not mentioned in the statement, the review commented that the UK's "unique soft power" is expressed through the UK's model of "democratic governance, legal systems and Common Law heritage" and institutions such as the BBC.

Police, Crime, Sentencing and Courts Bill

The Government introduced this Bill, covering an extremely broad spectrum of issues. The Bill sets out new rules requiring collaboration between authorities to prevent and reduce serious violence, a widening of the scope of offensive weapons, homicide reviews, and measures to restrict deliberately disruptive protests. The Bill will create a new statutory offence of public nuisance, in line with a recommendation made by the Law Commission in 2015, and reverse the law which currently prevents deaf jurors because a sign language interpreter would breach the rules about who is permitted in the jury room. The measures to address the desecration of war memorials and other statues through harsher penalties and the provisions relating to protest have caught the most public attention. Introducing the Bill, the Home Secretary made it clear that she had worked directly with the Police Federation in developing the measures. The Bill provides for a police covenant, similar to the military covenant, on which a report will be presented to Parliament annually.

COVID-19 and Education

The Education Select Committee heard from Catherine Roche, Chief Executive of children's mental health charity (and Lord Mayor's Appeal-supported) Place2Be and former Love Island star and Department for Education Youth Health Ambassador Dr Alex George on the impact of COVID-19 on the mental health of young people. Dr George explained his role to the committee in terms of using his social media following to help young people open up about mental health. Roche argued concerns about children's mental health had been growing before the pandemic, with the charity learning about more severe issues in children and young people in secondary schools following the resumption of schooling after England's first lockdown. The session gave some sobering statistics about the state of mental health in young people, with NHS benchmark reporting the greatest ever demand for child and adolescent specialist mental health services in November, up 20% on the year before. Dr George questioned the use of phrases such as "catch up" and "lost generation" because of their impact on the mental health of students.

Public Landmarks Review

Orpington MP and London Assembly Member Gareth Bacon (Con) led an adjournment debate on the Mayor's Commission for Diversity in the Public Realm. Bacon characterised Britain's heritage as being "under direct assault" from a "woke perspective" which sought to reinterpret British history "in a slanted and decontextualised manner" to justify "its belief that modern Britain is inherently racist." He argued that it was against this backdrop that the legitimacy of statues, monuments and road names was being questioned. Bacon criticised Sadiq Khan's use of public money to set up the "irresponsible and dangerous" Commission, which Bacon asserted was made up of "hand-picked, hard-left political activists" and intended to "tear down London's landmarks." He argued that the Mayor should instead focus on the "core functions" of his role, rather than "pushing ahead with [a] deeply divisive, virtue-signalling exercise." Housing Minister Chris Pincher agreed that the UK would be poorer if it sought to deny its history and set out the Government's 'retain and explain' policy. The Government, he said, would act "to ensure that our national heritage is protected from those who would seek to remove or deface it." The range of views expressed was limited by the thin attendance at the debate.

SNP Roundtable

The Policy Chair spoke alongside Emma Harvey, Programme Director at the Green Finance Institute at a roundtable event with SNP MPs. The event, "Civic Leadership and Green Finance in the transition to net zero", saw discussion of the role green finance can play in enabling projects such as the retrofitting of buildings to make them more energy efficient. MPs heard of the City of London's ambition to become the greenest financial centre in the world, as well as the City Corporation's Climate Action Strategy. There was also discussion of the City Corporation's aspirations for the COP 26 UN Climate Change Conference.

City Plan 2036

On 14 January, the Court of Common Council approved the Proposed Submission Draft City Plan 2036 for its final stage of public consultation. The City Plan 2036 has now been published for consultation and representations are invited. The consultation runs from **19 March until 6pm on 7 May**. It will be available online only in accordance with the Town and Country Planning (Local Planning) (England) (Coronavirus) (Amendment) Regulations 2020. The Proposed Submission Draft City Plan 2036, and other supporting information, is available on the [City of London Corporation website](#). Markets Co-location Programme – Outline Planning Application Approved

The programme to co-locate the three wholesale markets to a new site in Dagenham Dock continues to move at pace. On 22 March, the Policy Chair attended the London Borough of Barking and Dagenham's Planning Committee which decided unanimously to 'resolve to approve' the outline application for making Dagenham Dock the new home for the City's three wholesale food markets. This approval is a key milestone for the markets programme as we work towards starting the parliamentary process later this year. Bank Junction public consultation

The public consultation on proposals to change how Bank Junction operates will launch on the week beginning 29 March and will be open until 7 May. The All Change at Bank project is looking towards the future of the area around Bank Station. The underground station upgrade is due to open at the end of 2022. The proposal is to further restrict motor vehicle movements on three of the arms (Threadneedle, Princes and Queen Victoria Street) 24 hours a day, seven days a week. This will deliver a simplified layout of the junction and provide the opportunity to deliver substantial improvements for people who walk and cycle, and to provide greening and seating to improving the spaces that people can stop and rest. The proposals assume that traffic returns to 2019 flows (worst case) and that the temporary COVID-19 restrictions are no longer required. It is recognised that some of the temporary restrictions could be in place for some time to come. Initial work has been undertaken to understand whether this will prevent some of the Bank proposals being progressed. Letters have been sent to all City residents to notify them of the consultation. Businesses, workers, visitor and students are being engaged through various established outlets. In addition, several virtual town hall meetings will be held for stakeholders to learn more about the project as well as ask questions. Virtual visit to North America

In February, the Lord Mayor and the Policy Chair undertook a joint virtual visit to North America to engage with the senior leadership of key investors such as JP Morgan, Fidelity, Aon and OTPP. Conversations focused on global COVID-19 recovery, the future UK-North America relationship and the UK's ongoing competitiveness, with a focus on innovation, and environmental, social and governance matters in the run up to COP26.

Global Solutions to Global Problems: Promoting Regulatory Coherence in Financial Services for Pandemic Recovery

On 18 March, the IRSG (International Regulatory Strategy Group) published its latest report, "[Global Solutions to Global Problems: Promoting Regulatory Coherence in Financial Services for Pandemic Recovery](#)", which calls on global stakeholders to reaffirm their commitment to regulatory coherence to support a digital and green pandemic economic recovery. The report suggests that by making a renewed commitment to regulatory coherence, policymakers will support progress on challenges to future economic growth, such as climate change, cyber-crime and financial crime. To launch the report, there was a virtual event which included a keynote address from Dietrich Domanski, Secretary General, Financial Stability Board.

City of London: an ecosystem enabling international trade

On 24 February, the City of London Corporation and EY published a new report "[The City of London: an ecosystem enabling international trade](#)", which demonstrates how the UK's financial and professional services (FPS) ecosystem supports internationally exporting firms up and down the country. With the UK reshaping its economic relationships with key global markets, and the UK Government positioning international trade as a central pillar of the post-COVID-19 recovery, there is an opportunity to look anew at how UK-based FPS can support even more firms across all sectors of the UK economy trade internationally. Over 200 participants joined for the virtual launch which included a keynote speech from Rt Hon Greg Hands MP, Minister of State for Trade Policy.

The Recovery Taskforce

The final recommendations of the Recovery Taskforce have been drafted and will go to the Policy & Resources Committee and the Planning & Transportation Committee in the coming weeks. Pending approval, the recommendations and corresponding actions will be launched at an event in late April, entitled 'The Square Mile: Future City.' The mission of the Taskforce is to ensure the Square Mile is the world's most innovative, inclusive and sustainable business ecosystem, an attractive place to work, learn, live and visit. By delivering the long-term success and recovery of the Square Mile, we can ensure it plays its full part in driving the recovery across London and the rest of the UK. The recommendations span three dimensions:

- World-class business ecosystem (i.e. thriving businesses with innovation and growth opportunities)
- Vibrant offer (leisure offer, i.e. retail, hospitality, culture, tourism and recreation)
- Outstanding environments (i.e. the right workspaces, environment, and infrastructure)

City Bridge Trust (CBT)

COVID funding support via the London Community Response Fund (LCRF)

On 11 January, the Town Clerk, in consultation with the Chair and Deputy Chair of the CBT Committee, allocated £4m of the 2020-2021 CBT 'Bridging Divides' (BD) budget to Wave 5 through the LCRF, and £1m towards aligned expenditure (also from the 2020-2021 BD Budget). Expenditure of the £4m LCRF funds is now underway. A donation of £250,000 was also received from Macquarie Bank, bringing the total available for Wave 5 expenditure to £4.25m.

Flexible Funders

CBT has signed up to the Flexible Funders campaign run by the Institute of Voluntary Action Research (IVAR) and London Funders (the charity enabling the membership network for funders and investors of London's civil society). The campaign calls on funders to adopt more open and trusting practices that make life easier for those we fund, in light of the ongoing uncertainty caused by COVID-19. Global Recycling Day – 18 March

In recognition of Global Recycling Day on 18 March, the Recycling and Clean City Award Scheme (CCAS) Team hosted an online meeting for all staff reinforcing the importance of recycling and waste reduction. The presentation and supplementary information is available upon request.

Environmental awards given out at the first virtual Clean City Award Ceremony

The City of London Corporation's Recycling and CCAS Team ran the first ever virtual Clean City Awards Ceremony on 22 March. Hosted by the Chairman of Port Health and Environmental Services Committee, Keith Bottomley, the businesses leading the way in improving environmental performance were: Bank of England in the Air Quality and Climate Action category; Investec in Plastic Free City category; Broadgate in Resource and Circular Economy category; and Investec in Communication and Engagement category. The Bank of England and 1 Angel Court were the respective winners in the Large Site and Facility Management categories in the Chairman's Cup, for which this year's theme was "embedding environmental performance and sustainability during the COVID outbreak". The City becomes the first place in the UK to run a fleet of Electric Refuse Collection Vehicles

The new fleet of Electric Refuse Collection Vehicles (ERCV) will form the UK's first zero emission recycling and waste collection fleet and will collect residents' waste and recycling in the Square Mile. The first ERCV arrived on 4 March, with more to follow. It is anticipated that the new fleet of vehicles will collect approximately 20,000 tonnes of residential recycling and waste over the next six years. The pollution-busting ERCVs are part of the City Corporation's plan to ensure at least 90% of the Square Mile meets World Health Organisation guidelines for nitrogen dioxide by 2025. The introduction of this fleet of vehicles also aligns with the Climate Action Strategy goal for the City Corporation to achieve net zero carbon emission by 2027.

Schools Reopening

The City of London Family of Schools welcomed most pupils back to school on 8 March, although for many there was a consistent in-school contingent during the national lockdown. The Schools are working with parents and pupils to ensure information and advice on testing, masks, arrival and leaving times, school transport, corridor protocols, handwashing, and other processes are clearly communicated and understood. The Government announced that the statutory Key Stage 1 and Key Stage 2 tests for this summer have been cancelled and primary schools will use internal assessment data for results. Furthermore, GCSE and A-Level examinations have also been cancelled and grades will be awarded based on teacher assessments. The Education Unit continue to engage with Schools during the process of reopening including through regular engagement forums and pupil-based events.

Chess Tournament and Workshops (Virtual)

The Education Unit, alongside Chess in Schools and Communities (CSC), hosted the annual Family of Schools' Chess Tournament as an online event on 3 March. Over 80 pupils joined the Tournament on the day, facilitated by the online platform Chess Kid and between games, CSC facilitated discussions, tips and techniques and interactive conversations on past games and historic check mates. Two training sessions for pupils took place prior to the tournament, who conducted themselves in a professional manner showcasing their extensive knowledge and passion, as well as being enthusiastic players. All pupils who took part in the tournament received a year's free subscription of a gold Chess Kid account. The Chess Tournament also provided an opportunity for Fusion Skills development including problem solving, initiative, critical thinking, resilience and analysis, and evaluation skills.

London Careers Festival

The London Careers Festival will take place again this year and will be hosted virtually between 28 June and 2 July for primary, secondary and post-16 pupils. The event is designed to connect pupils with the world of work so that they are introduced to the diverse array of opportunities offered across Greater London and beyond, and to fuel their imaginations and inform their futures. City of London School for Girls (CLSG)

After two full months of learning from home, broken up by a one-week holiday to relax at home, March began with the exciting news that students and staff would be able to return once more to the Barbican site. This was facilitated, of course, with a gargantuan testing effort. Previously a space for rehearsals and assemblies, CLSG's New Hall was transformed into a purpose-built asymptomatic testing centre complete with six adjacent booths and a friendly group of trained alumnae, garbed in full Personal Protective Equipment and ready to assist students through the self-swab process. In the ensuing week and a half, over 2,000 lateral flow tests were performed on nearly 700 students from year 7 through to year 13, with home-testing kits distributed for all to continue the now-familiar process at home. It certainly seems fitting that as everyone is approaching the Easter holidays from our physical classrooms, talking to non-pixelated faces, that the sun has come out – a warm and hopeful end to the term in more ways than one.

Snapshot of some upcoming lectures

[What do we owe to those not yet born?](#) 13 April, 6-7pm, online, free (or watch later)

Climate change and the over-exploitation of resources now may mean that unless the current generation modifies its behaviour, generations ahead may either not be born or will inherit a world with severe problems. A village or even a nation state can develop rules to prevent depletion of resources so that it does not cut down forests or over-fish the oceans. In this lecture Professor Martin Daunton asks, how can that be done globally when the action of one country can have a harmful effect on another?

[Where do Mathematical Symbols Come From?](#) 27 April, 1-2pm, online, free (or watch later)

Where do we get our mathematical symbols from? Why is the set of integers called Z ? When was the equals sign first used? How about zero? Good notation tends to catch on quickly, whereas bad notation can obscure beautiful theory. The lecture by Professor Sarah Hart explores how the introduction of new notation has paved the way for new leaps in understanding, and considers some mathematical quirks of language, such as what the number four in English has in common with the number 11 in Russian.

City of London Police Authority Board

The Black Lives Matter movement in May 2020 and more recent public vigil for Sarah Everard sparked wider conversations around the importance of legitimate, representative and proportionate policing across communities. Both events also drew attention to a greater need to increase public consultation - with focus on inequality issues to enhance understanding and improve service delivery particularly in respect to personal and public safety. The City Corporation has been looking at these issues for some time and assembled a Taskforce to assess what actions it could undertake to listen, engage and consult with the wider public, in order to promote better economic, educational and social inclusion across all its activities. This resulted in the publication and endorsement of the Tackling Racism Taskforce Report by the Policy & Resources Committee on 21 January and the Establishment Committee on 27 January. Following the publication of this report, the Police Authority Board developed a Diversity and Inclusion statement in response to the Taskforce's recommendations, outlining the Board's commitment to ensuring it's legal obligations under the Equality Act 2010 and associated Public Sector Equality Duty in respect to recruitment, training, retention and working practices. The statement was approved by the Board on 25 March and will align with the City of London Police Equality & Inclusion Action Plan set to be published shortly. The Police Board will work closely with the City of London Police, City Corporation, wider partners and stakeholders to ensure all aspects of its work and service delivery meet the objectives outlined in the Diversity and Inclusion statement. COVID-19 regulations

The City of London Police continues to police the regulations in a proportionate and appropriate way, in line with the 4Es approach - explain, engage, encourage, enforce.

Violence Against Women and Girls

On Monday 15 March, there was an extraordinary meeting of the National Chief Constables Council, to discuss violence against women and girls. While being abducted from the streets is thankfully rare, violence against women and girls at the hands of men is not, and policing is fully alive to the pernicious harassment women suffer that limits their freedoms. A key issue for policing is the effectiveness of our response to violence against women, particularly in relation to rape, domestic abuse and stalking. In the City of London, we share the commitment to see meaningful change come from Sarah Everard's death and we will carefully consider in the coming weeks how we can contribute to this change.

Citizen Science air quality monitoring

The City Corporation's Air Quality Team has launched a project giving residents the opportunity to measure local air quality for 12 months, seven years after a similar study took place. The initiative is being run with residents of the Barbican and Golden Lane Estates, with the support of social enterprise Mapping for Change. It aims to demonstrate the improvements in air quality that have occurred since the original Citizen Science programme and the value of community input in tackling local environmental issues. Several recommendations made by residents during the initial project have been implemented leading to improved air quality, including a three-year Low Emission Neighbourhood programme implementing electric vehicle charging points, green infrastructure, cargo bikes and a zero-emission street pilot.

Spring Dramas: All Your Houses and Jackal Run

Final-year actors and production artists at Guildhall School have worked with two multi-award-winning theatre companies to create two brand new pieces of contemporary theatre, available to view from 14 April, 7.30pm. In *All Your Houses*, created with theatre company Barrel Organ, 14 people look out of their bedroom windows. Something is coming, so they look to each other for help, only to find that they are alone. Forced to turn inwards, they unearth figures from the past, who can perhaps help them with their present. *Jackal Run*, created with theatre company Breach, is inspired by real events and uses a blend of real witness testimony and imagined characters to tell the story of a group of British women who discover their partners are undercover police officers. Each of their stories – spanning several decades of deception, manipulation and surveillance – are remarkably similar, and now they are looking for answers.

Final five bridges of Illuminated River to be lit in Spring 2021

Illuminated River is a public art commission to light up the bridges of the Thames, delivered by artist Leo Villareal, who uses the latest LED technology to 'paint with light', and architects Lifschutz Davidson Sandilands. Guildhall School composers and electronic producers have been commissioned to create original scores inspired by the context and architecture of the bridges. London Metropolitan Archives (LMA)

Haringey's BAME LGBTQ+ history has been secured for future generations with the help of LMA and the National Lottery Heritage Fund. Since July 2018, LMA has been working with Haringey Archive and Museum Service (HAMS) to support the Haringey Vanguard Collection (HVC) at Bruce Castle Museum, a BAME LGBTQ+ History project focused on the history and contributions of Haringey-based community activists in the 1970s–90s. The impact of the project has been felt well beyond Haringey, improving access to existing collections and encouraging the donation of new material. This has brought together formal records with personal and community collections, enriching wider Haringey LGBTQ+ history and ensuring the preservation of this important history by placing older BAME LGBTQ+ residents' experiences at the heart of the project.
