# LORD MAYOR

## **Service of Remembrance, Thanksgiving and Hope**

The Lord Mayor conceived and arranged this special Service which was held at St Paul's on 22 June to provide a moment of solemn reflection for those who had died from COVID-19 and to give thanks for the gradual return of life to the City. The service was attended by a wide range of City stakeholders, from Common Councillors to Liverymen and medical workers to teachers. The Bishop of London delivered the sermon.

## **Reopening Campaign**

The Lord Mayor's reopening campaign continues, highlighting the return of activity to the Square Mile. In June, the Lord Mayor visited Eataly, the Noel Coward Exhibition at Guildhall Gallery, the Guildhall Lunch Market, art installations popping up in vacant city windows, and opened Number One Lombard Street. He also visited Aldgate Primary School, the cultural art installations in Aldgate Square, and visited Hampstead Heath with a group of Members to celebrate the 150<sup>th</sup> Anniversary of the Hampstead Heath Act.

## **World Economic Forum (WEF) Regional action group**

The WEF Regional Action Group for Europe and Eurasia meeting on 29 June on 'Accelerating the Digital Transformation' considered how applications of Artificial Intelligence, blockchain and the Internet of Things should be leveraged by the private sector and governments to foster excellence, trust and inclusion. The Lord Mayor shared thoughts on how emerging technologies play a vital role in London and the UK's economic recovery, helping to boost the productivity of new hybrid workforces and fulfil the potential of a newly connected UK. Other speakers of note included Xavier Bettel, Prime Minister of Luxembourg.

## **The Financial and Professional Services Address**

On 1 July, Mansion House hosted the Chancellor of the Exchequer and the Governor of the Bank of England for the Financial and Professional Services Address. The Chancellor thanked the sector for the role that it has played in supporting customers and businesses through the COVID-19 crisis and set out a positive vision for the position of the UK as a global financial centre. The Governor analysed the impact of COVID-19 on the economy and looked at the prospects for the recovery.

## **UK Saudi Investment Forum**

On 13 July the Lord Mayor gave the opening and closing remarks at the UK – Saudi Investment Forum. This event brought together Saudi and British investors with government representatives to discuss the partnership and investment opportunities available to support the transition towards greener and less oil dependent economies. The day was comprised of three panel sessions and a Ministerial lunch with His Excellency His Royal Highness Prince Khaled bin Bandar Al Saud (Ambassador of Saudi Arabia), Majid bin Abdullah Al-Qasabi (Minister of Commerce and Investment and Acting Minister of Media), and Lord Grimstone (Minister for Investment) in attendance.

## **Dinner with Secretary of State for BEIS and Saudi Minister Qasabi**

On 14 July, the Lord Mayor joined a private dinner hosted by the Rt Hon Kwasi Kwarteng MP Secretary of State for Business, Energy and Industrial Strategy, in honour of Minister Qasabi's visit to the UK. The dinner followed the second meeting of the Economic and Social Pillar under the Strategic Partnership Council of which the Secretary of State and Saudi Minister Qasabi are co-leads.

## **UK Board of Trade meeting**

The Board of Trade met in Glasgow on 21 July, as part of a drive by the Secretary of State for International Trade to connect with the Devolved Nations and English Regions. The Board heard updates from Crawford Faulkner, Chief Trade Negotiation Adviser & Second Permanent Secretary, on progress with several Free Trade Agreements, bilateral discussions, economic dialogues and mutual recognition agreements. This covered Australia (including the Comprehensive and Progressive Agreement for Trans-Pacific Partnership), USA, New Zealand and India, Canada and Mexico. Minister for Investment, Lord Grimstone, also updated the Board on the Office of Investment, the Investment Council, the National Security and Investment Bill, and on regional investment initiatives that were underway with key global markets. The Board also discussed the final version of the Department for International Trade Green Trade policy paper (to which the City of London Corporation had extensive input) and its planned launch that day. They also discussed the forthcoming Digital Trade and Data policy paper (which will be launched in the next Mayoralty) and the planned Board meeting in Belfast.

# CHIEF COMMONER

## Back in Great Hall after 16 Virtual Months

57 Members, just under half the Court, turned out for Common Council on 22 July 2021, our first meeting in person in Guildhall since 5 March 2020. Attendance would have been higher had some Members not fallen victim at the last minute to the Pingdemic. The seating in Great Hall was sensibly spaced and lunch was served in a relatively safe environment outdoors in the courtyard behind the North Wing entrance. I think I can speak for all Members who were there when I say that it was good to be back. We are hopeful of an even fuller court when we meet again after the summer recess on 9 September – provided we can do so safely – and we are also hopeful that by then the City and the City of London Corporation will be back to something approaching normal.



For those concerned about missing out by not being there, it is currently planned that any major decisions on implementing Lord Lisvane's recommendations will be taken at the following Court in October. Sheriff Christopher Hayward has heroically chaired no less than 22 meetings with Members on the Lisvane report and it is envisaged that a package of reforms distilled from these sessions will be put to the Court. Headlines are likely to include a reduction in the number of committees, sub-committees and working groups from 140 to just under 100, beefing up powers of delegation, and holding fewer but more strategically focussed meetings.

Members using the West Wing during the heatwave in July will have experienced unacceptable conditions. I have looked into this, and like many things in the City Corporation you need to drill down several layers to get to the real story. In a nutshell the air conditioning in our 1970s building is held together with bits of Elastoplast. The current system is 25 years old and has reached the end of its economic life and is in need of replacement. A capital project to replace the west wing chiller plants has been approved but unfortunately work won't be completed until mid-2023. Meanwhile, officers are continuing to investigate temporary solutions to cope with extreme high temperatures, including standalone air conditioning units in committee rooms and individual offices, solar reflective film in more areas and more effective blinds.

More than two decades after the issue was first raised, the Court has finally approved a scheme for paying Members a small allowance. The primary objective is to make the Court more inclusive, with the new allowance claimable from October so that the system is up and running in time for next year's elections. The scheme also retains the previous support available to those who suffer loss of earnings. More details will be provided later, but it is planned that a simple drop-down menu will enable Members to register on-line to claim a flat rate of £7,500 per annum, payable on a quarterly basis. Those who chose not to claim remain unaffected by the scheme and will retain their voluntary status.

# CHAIR OF POLICY & RESOURCES

## **Professions meeting with the UK Ambassador to the WTO**

The Policy Chair co-chaired a meeting with the Professional and Business Services Council's International Trade Group. The Group was joined by the UK Ambassador to the World Trade Organisation (WTO), Simon Manley who raised the delivery-focused and business-minded approach being taken by the WTO's new Director-General and communicated his intention for reciprocal business-government support. One key theme is that EU exit work is being dialled down.

## **Virtual Visit to India**

The Policy Chair conducted a virtual visit to India between 30 June-2 July. The aim of the visit was to deepen links with key Indian financial and professional services stakeholders, in lieu of the annual in-person visit to the region, in addition to promoting the City's confidence post-Brexit and through COVID-19. The key showpiece of the programme was the launch of the City of London Corporation India-UK Capital Markets Working Group's first report Unleashing the potential of the Indian Debt Capital Markets. The report provides an initial set of recommendations to increase the depth of corporate bond markets in India. The Policy Chair publicly launched the report along with the Group's co-chairs, who provided an overview of the report's focuses and group's objectives. The strong links between the UK and India was a recurring theme throughout the visit and reinforced in meetings with the new president of the Confederation of Indian Industry (CII), Mr. T V Narendran and HM Trade Commissioner for South Asia, Alan Gemmell. Fintech was also a key focus of the visit. The Policy Chair hosted a private discussion that convened UK and Indian fintechs and experts to discuss the current flows and barriers for Indian fintechs entering the UK market.

## **Launch of the HM Treasury Women in Finance Charter Review**

The Policy spoke alongside John Glen MP (Economic Secretary to the Treasury and City Minister) and senior representatives from Refinitiv, Aviva and Virgin Money to look at progress made over the past five years on increasing female representation in the financial services sector since the creation of the Charter. The event was organised by the thinktank New Financial, and their work on this is sponsored by the City Corporation

## **Children's book on "How the City Works"**

The Policy Chair attended the launch of "How The World Really Works: City of London" a book for children explaining the history and work of the City of London. She attended alongside the publishers Guy Fox and the illustrators of the book – children from Aldgate School, who now proudly have their artwork in print. The project was partly funded by the City Corporation's Policy Initiatives Fund.

## **Social Mobility Taskforce**

On 7 July, the Policy Chair spoke about the City Corporation's role in leading the Government-commissioned taskforce which seeks to boost socio-economic diversity within UK financial and professional services. The taskforce is working with 100 employers to ensure progression is led by performance and not just 'fit' and 'polish'. This runs alongside the City Corporation's other Social Mobility efforts; outlined in our Social Mobility Strategy. ## **Virtual roundtable with the Slovenian Ambassador to the UK**

At the start of the Slovenian Presidency of the EU, the Policy Chair led a virtual roundtable discussion with H.E. Simona Leskovar, the Slovenian Ambassador to the UK. The meeting explored the role of financial services in supporting the economic recovery, the UK's bilateral relationship with Slovenia, and Slovenia's EU presidency priorities, including developments on sustainable finance.

## **Virtual roundtable with the French Ambassador to the UK**

The Policy Chair led a roundtable with H.E. Catherine Colonna, Ambassador of France to the UK, which was attended by representatives from The City UK, the International Regulatory Strategy Group, and the financial and professional services sector, to discuss recovery from the COVID-19 pandemic, sustainability, financial inclusion and the role of technology.

# PARLIAMENTARY/GLA

## Crossrail

Transport for London Commissioner Andy Byford and Crossrail chief executive Mark Wild gave evidence to the Public Accounts Committee (PAC) on Crossrail's progress. Wild told the PAC that the line was in the trial running phase, "almost the penultimate stage" before trial operations, which would start in the autumn. This would allow an opening window in the first half of 2022, with February given as the earliest date. Wild outlined the impact of COVID-19, which had cost the operation £230m, though he noted the scheduled work lost during the initial lockdown had been made up subsequently. Department for Transport Permanent Secretary Bernadette Kelly did not expect further increases in the cost other than those already identified in the recent National Audit Office report, a point echoed by Byford. Concerns over borrowing and the longer-term impact of COVID-19 on working patterns was also discussed.

## London and the COP26 UN Climate Change Conference

The London Assembly's Environment Committee took evidence on London and COP26 from GLA officers Pete Daw and Elliot Treharne, the City Corporation's Environment Committee Chair Keith Bottomley, climate activist and lawyer Farhana Yamin, and Frances Way, executive director of the Climate Champions team supporting the COP26 High Level Champion for business, cities and civil society. Asked about the part of London in combating climate change, Way stressed the key role of cities as centres of commerce, culture and innovation. She emphasised the need for transport decarbonisation and role modelling for others. Bottomley noted that societies were increasingly urbanised, and so cities were crucial to climate mitigation. He noted there was a clearer understanding now of the action required to decarbonise cities and highlighted the importance of finance. He added that COP26 was an opportunity to demonstrate the willingness of the private sector to finance the transition to net zero. Pete Daw outlined the aims of the Mayor's engagement with COP26, though was pressed to provide more detail to the Committee. Bottomley said that the Mayor of London could have a platform at the summit if the agenda was right. It was important, he said, for the summit to not just be "finance talking to finance," and noted the work being done by the City Corporation in the run-up to November and to convene stakeholders at the event. He advertised the City Corporation's willingness to collaborate with City Hall, London Councils and others on COP26. Asked whether the Mayor's Environment Strategy was urgent enough, Bottomley stressed the importance of plans being deliverable, affordable and fundable. The funds required for retrofitting were significant, but there was no shortage of private funding looking for decarbonisation opportunities, he added. Daw discussed City Hall's engagement with the Green Finance Institute on the London Finance Facility and said ideas to accelerate funding would be developed over the summer.

## London's River Crossings

The London Assembly's Transport Committee took evidence on London's river crossings from Bridge House Estates' Managing Director David Farnsworth, David Rowe and Gareth Powell from Transport for London, the Port of London Authority's John Stevenson, Tom Osborne of bridge specialists Knight architects, and Michael Horodniceanu, the former traffic commissioner of New York City. Powell and Farnsworth offered an overview of how the river crossings under the control of their organisations were managed and maintained, including the use of 50-year maintenance plans. Asked about the challenges faced in maintaining their bridges, Farnsworth noted the coordination required with different stakeholders to close a bridge for maintenance, while Powell cited the costs associated with maintaining heritage assets, the working environment and the inability to shut for long periods of time. David Farnsworth had noted that the Bridge House Estate's endowment allowed it to fund its bridge repair work, much of which was proactive. Pressed on how TfL funded its maintenance programme, Powell argued that the lack of a sustainable long-term funding arrangement for TfL prevented it from proactively maintaining its crossings. Ultimately, unsafe assets could be closed, he said, or speed and vehicle restrictions imposed to increase the asset's longevity. Asked about the lessons of the Hammersmith Bridge situation, Osborne asserted that London was too reliant on existing crossings and needed more, especially in the east of the city. Shaun Bailey (Con) asked if TfL should be given full control of London's river crossings, including where it was not currently the asset owner. Powell argued that funding for TfL was the more important issue, followed by coordination as interfaces would always exist. He spoke positively of the current coordination at various levels with asset owners such as Bridge House Estates. Sian Berry (Green) asked if Bridge House Estates would be interested in taking on more bridges, to which Farnsworth outlined the limitations of the charity's objects. Chair Caroline Pidgeon (Lib Dem) asked if a sink fund on the model of Bridge House Estates could fund repairs for other asset owners, and Powell replied that it would be one possibility.

## COVID-19 rapid testing outreach to the City's SMEs

One in three people with COVID-19 does not have any symptoms of the disease and may be spreading it without realising. Rapid (lateral flow) COVID-19 tests can help to identify when someone has the virus and needs to self-isolate. It is recommended that everyone without symptoms tests twice a week. These tests are free and widely available. In addition to helping keep staff and customers safe from COVID-19, frequent rapid testing can also help to avoid business disruption as a result of workplace outbreaks. As part of its COVID-19 testing programme, starting from 27 July, the City of London Corporation will be conducting twice-weekly outreach to Small and Medium-sized Enterprises (SMEs) in the Square Mile on Tuesday and Thursday afternoons. These will focus on hospitality, retail, and close-contact service businesses where staff are more likely to be in public-facing roles. This initiative is being supported by the City Corporation's Public Health and Environmental Health teams. The outreach team will visit businesses to talk to them about the benefits of frequent rapid testing and provide them with boxes of rapid test kits. In addition, they will provide basic signposting about other COVID-19 related support available to local businesses, such as information about financial support that individuals on low incomes who need to self-isolate can apply for, and how to report positive COVID-19 cases to the City and Hackney Public Health team. The outreach will take place on a ward-by-ward basis, and information will be made available on the City Corporation website and social media channels. ## Innovation & Growth Directorate

### The UK Regime for Overseas Firms

As a core contribution to the City of London Corporation competitiveness strategy, the International Regulatory Strategy Group (IRSG) launched a new report, [The UK Regime for Overseas Firms](#), focused on regulatory openness. It was the first IRSG event featuring the new IRSG chair, Dr Kay Swinburne who set out her vision for the IRSG. The event featured a keynote address by the Economic Secretary to the Treasury, John Glen MP, who outlined the follow up to the HM Treasury call for evidence on the overseas framework and a suite of consultations, including on the Overseas Person Exclusion launching in the Autumn.

### Digital Sandbox

Three case studies were unveiled for the Digital Sandbox's sustainability cohort on 20 July. Innovators with tech solutions tackling challenges around ESG data and disclosures will be invited to apply to take part in the second phase of the Sandbox, a unique collaboration between the City Corporation and the Financial Conduct Authority. ### Finance for Sustainable Growth

The City Corporation launched the [Finance for Sustainable Growth \(F4SG\)](#) North East pilot, focused on enhancing the visibility of North East green innovation and Greentech start-ups to London-based and international investors - in support of reaching net zero by 2050 and levelling up across the country. With a speech by Stephen Welton – executive chairman of BGF – and a panel discussion chaired by the City Corporation's Policy Chair, the event focused on demonstrating the strengths of the North East sustainable business ecosystem. to mobilise and scale up sustainable finance, and why the UK is well-positioned to be the upcoming international green finance hub.

## **Bridge House Estates (BHE) and City Bridge Trust (CBT)**

### **BHE Board Meeting**

On 14 July, the BHE Board held its second formal meeting and agreed the establishment of a Grants Committee of the Board to have delegated responsibility for the application of funds allocated to further the charity's ancillary objective in accordance with the Bridging Divides Strategy. It is anticipated that the Grants Committee will first meeting in late September. Members will also recall that there are several specialist induction sessions scheduled from various teams in the charity to support the Board.

### **Blackfriars Bridge**

On 18 June, the City Corporation (in its capacity as Trustee for BHE) appointed FM Conway, in partnership with Taziker and Alltask, for the multimillion-pound repaint and refurbishment of Blackfriars Bridge, protecting the fabric of the structure to increase its longevity.

### **CBT Committee**

In March 2021, the former CBT Committee agreed a set of 11 change recommendations following a review of the Bridging Divides Strategy. CBT has also developed ambitious plans for its work on diversity, equity, inclusion, and the delivery of its PACIER values (progressive, adaptable, collaborative, inclusive, environmentally responsible and representative). It is expected that CBT will restart its main strands of grant-making in the Autumn.

## **Skateboard GB event in Guildhall Yard**

The City Corporation's Sport Engagement Manager has been working with Skateboard GB – the national federation for skateboarding – on an event to coincide with the UK active National Conference taking place at Guildhall on 13 October. A temporary structure will be installed in Guildhall Yard for the day as part of a travelling skateboard activation taking place across the country. ## **Open Spaces**

### **Come, explore and celebrate 150 years of the Hampstead Heath Act**

The Hampstead Heath Act 1871 preserved the original Heath as a public open space. It was a significant moment in the protection of the Heath and the role of green spaces. As part of the 150-year celebrations there is a great informative, historic and educational outdoor exhibition on display until 8 August. It tells the story of the campaign to save the Heath, and also looks at aspects of the Heath over the past 150 years, including its importance for nature, leisure, sport and culture, along with the important role played by the people and organisations who continue to work to protect it for the enjoyment of everyone. The display is located at the South End Green entrance to the Heath, near Hampstead Heath overground station.

### **Improved access to Wanstead Park for cyclists**

The City Corporation has extended permissive cycling in the eastern areas and on the main paths of Wanstead Park. Previously a historic byelaw restricted cycling in this specific area of Epping Forest. In a consultation earlier this year, over two-thirds of respondents wished to see these rules around cycling in the park relaxed. More people than ever are enjoying visiting Epping Forest by bike and indeed this is a very beneficial way for people to arrive at the ancient woodland, meaning that the Forest experiences less pressure from cars travelling through the local roads. In addition, those opting to cycle also experience the wealth of health benefits which come from using pedal power as a mode of transport.

### Domestic Abuse Awareness & Insight Hour

London Careers Festival took place between 28 June and 2 July, aiming to connect pupils to the world of work. It introduces them to the diverse array of opportunities offered across Greater London and beyond, fuels their imaginations, develops their skills and inspires their futures. In 2021, London Careers Festival offered a range of webinars and resources for primary, secondary pupils and post 16 pupils. In fact, there were over 50 skills and employer webinars with Natwest, PwC, CISI, Bloomberg, Evening Standard, Role Models and many others exploring careers in Science, Technology, Engineering, Maths, Art, Media, Business, Law, etc. For example, CISI delivered webinars to secondary and post 16 pupils looking at career pathways within financial services and exploring the role 'trust' plays in the industry. For the first time, the festival also had provisions for SEND pupils working closely with grass-roots organisations at local and national level to engage pupils in careers education. ### Evolve Project

Westminster Council, the City of London Corporation and Lewisham Council collaborated on the Evolve project, supported by a grant from the Greater London Authority and London Councils' Evolve programme. This grant supports cross-borough collaborative working between culture officers. As part of this project, a short film was created and is based on the vast array of little known behind-the-scenes roles in the film industry for young people aged 11-14 and their parents. The film offers insights into the wide scope and range of careers in the film industry; how people access these jobs, what qualifications and skills they might need, and what they could expect to earn in this industry. ### Equalities Conference

To further the existing practice and leadership of equalities work across all academies, the City of London Academies Trust (CoLAT) central team hosted a conference for academy leaders focused on creating an equalities culture in schools aligned with the Trust-wide values of integrity and care. The conference was a platform for academy principals to spotlight an area of effective practice in their school to share with the other schools for knowledge exchange and peer-to-peer learning and development. Examples of work occurring in the academies shared in the conference included: systemising equalities across all aspects of school life; positive LGBTQ+ activities across the year; diversifying the English literature curriculum



to ensure that texts are sharing a range of stories and perspectives; inclusive working practices for school staff; addressing achievement in underperforming groups; using culture and creativity to promote diversity in the curriculum; considering assessment practices to address potential unconscious bias; and promoting student voice and ensuring everyone is invited to speak and share. The exemplars of excellent practice will be shared across the Trust, encouraging schools to partner up on initiatives, and the equalities agenda will be a regular feature on the termly CoLAT leadership conferences. This work across CoLAT schools is closely aligned with the City Corporation's action plans for the Education Strategy, the Social Mobility Strategy, and the Tackling Racism Taskforce recommendations.

However, financial literacy is rarely taught at schools; instead, the principles of finance are typically reserved for expensive MBA programmes. This lecture series by Professor Alex Edmans aims to make essential financial skills available and accessible to everyone, and also demystify financial jargon so that we can understand financial documents, reports and articles.

### [The Hidden History of How Protestantism Went Global](#)

In this series Professor Alec Ryrie will tell the story of Christianity's global spread, which is usually told in two parts: first the conquistadores took Catholicism to the Americas and elsewhere in the 16th and 17th centuries; and then the global empires of the 19th and 20th centuries brought Protestant missionaries to most of the rest of the planet. This lecture series takes us into new research revealing the forgotten piece of the puzzle connecting those two stories. These hesitant early missionary ventures did not win many converts, but they formed Europeans' assumptions about 'race', 'justice', 'civilization', 'religion' and the nature of Christianity itself. Find out how their experience primed the age of Christian expansion which followed, producing worldviews which still underpin our own secular age.

## **City of London Police Authority Board**

### **Police Authority Chair appointed to the Association of Police & Crime Commissioner's (APCC) Board**

The Chair of the City of London Police Authority, James Thomson CC has been appointed to the Board of APCC. He will represent the other police governing bodies which include the Mayor's Office for Policing

and Crime for the Greater London Authority, British Transport Police Authority, Ministry of Defence Police Committee and Civil Nuclear Police Authority. James Thomson is also the APCC Deputy Lead for the Economic and Cyber Crime Portfolio. Within this role, he champions the economic and cyber-crime agenda and seeks to raise fraud as a priority in local crime and policing plans while providing a channel to share the views of PCCs with key central stakeholders, particularly the Home Office. The APCC is the national body that supports Police and Crime Commissioners and other local policing bodies across England and Wales, to provide national leadership and drive strategic change in the policing, criminal justice and wider community safety landscape, to help keep our communities safe.

### **New City of London Police Commissioner**

Angela McLaren is set to be appointed as the new City of London Police Commissioner, following a meeting of the Court of Common Council. The appointment, which is subject to Royal Assent, will see the new Commissioner lead the City of London Police. Since December 2020, she has served as Assistant Commissioner for Economic and Cybercrime, a recently created position in recognition of the force's increasing national responsibilities, providing strategic leadership, and driving the national policing strategy on these growing threats. Angela McLaren will replace Commissioner Ian Dyson, who announced his planned retirement after 38 years of distinguished service in policing, with six of them as Commissioner. The recruitment process was overseen by the City of London Corporation's Police Authority Board, with the appointment reported in the media by [Police Professional](#), [City Matters](#) and [Police Oracle](#).

The new business partnership will meet again in October to discuss emerging priorities for the area.

**Creative Learning:** A partnership of 27 cultural organisations, supporting learning and social mobility through a schools and young people programme.

**Creative Spaces:** Developing the spaces within Culture Mile.

Play Nice, winners of Culture Mile and Foundation for Future London's £50,000 Fusion Prize have launched Gaia's Garden in partnership with property developer Dominvs Group. Developed by five young female creatives, the free community garden at 61 Holborn Viaduct will be open until September, with a live events programme focused on sustainability.

**Creative Collaborations:** Developing the City's creative ecology and deeper relationship between commerce and culture.

The Culture Mile team will be using BE Offices, Beech Street as a hub for creative collaboration, throughout the summer, as part of the Culture & Commerce Taskforce Create in the City initiative – a pilot project recommended in the Fuelling Creative Renewal report.

**Creative Communities:** Strengthening connections with our neighbours and the culture on their doorstep.

The City Corporation's Neighbourhood Fund has approved Culture Mile's bid for their Creative Communities work, subject to an annual review. Funding is agreed in principle for the next three years and will allow the team to build on work started at the beginning of the pandemic. Plans this year include outdoor family play events, and the Creative Citizens Lab, which will find new ways for residents to create their own creative projects.

Applications are open until 30 July. SBREC staff supported the London Careers Festival organised by the Department for Community and Children's Services with presentations for secondary and post 16 students on starting a business. These presentations were very well attended by students from across London's schools and colleges.

## Webinars for Entrepreneurs

SBREC has hosted a full suite of webinars this month for entrepreneurs including Market Research for Small Business presented by SBREC staff and a three-part course on The Entrepreneurial Mindset, challenging and coaching business owners to achieve what they want in their business. In addition, staff have presented a Start-up Essentials webinar on behalf of Business for London.

## Collaboration with Enterprise Exchange

SBREC staff have continued to reach out to other business support organisations to promote the Centre and have started working with Enterprise Exchange which supports ex-offenders in their self-employment journey. The work will continue over the summer to support people on their self-employment journey.

# London Metropolitan Archives (LMA)

## Royal College of Surgeons of England in partnership with LMA

From 2017 until July 2021 the Royal College of Surgeons (RCS) of England archive was based at LMA while the College building was closed for re-development, enabling RCS to keep its archive reading room and enquiry services running throughout. The RCS archive collections were moved into the LMA store, its service users viewed its collections in the LMA archives study area and its archives team were based in the LMA office. Being based at LMA raised the profile of RCS Archives and was a great opportunity for staff from a small, specialist repository to see how a major record office operates, to learn from the expertise of LMA and to work collaboratively. RCS Archives will be reopening in the new building in Lincoln's Inn Fields in the autumn (see [the RCS website](#)).

## Bringing community groups back on site

LMA has started running test events to bring community groups back on site. The first was a group of care-experienced young adults working on the Coram's National Lottery Heritage Fund project [Voices Through Time: the Story of Care](#). These young people saw a selection of documents from Coram's Foundling Hospital archive including the billet books in which mothers left small tokens (usually scraps of fabric) so that should they be able to take their child back they could be identified; and items that gave them a feel of the everyday life of the hospital including school books and dinner menus. They also took a behind-the-scenes tour around the building, learning more about how the documents are stored and used.
